DAN WALTERS: Literally every year we've played at least one practice round together in this. Obviously they won in Birmingham, we lost in the semis, could have played them in the finals. To be honest, I would have liked to see them later in the week, but that's just how the cookie crumbles.

Q. Is it easier to play guys you know or guys you don't have any clue who they are?

EVAN BECK: Didn't give it much thought, to be honest.

DAN WALTERS: Just trying to play.

Q. Your thoughts of maybe -- you're two wins away from another USGA title in eight months.

EVAN BECK: A lot of golf left. I think it's going to be -weather is going to be tricky tomorrow, so we'll keep doing what we're doing.

Q. What has clicked all week for you guys?

EVAN BECK: Dan and I were talking about it a lot. It seems like the more golf we're able to play, the more we can figure out how to play again. It's been nice to get a couple rounds in a row.

DAN WALTERS: Totally agree. I think in the stroke play we were sketchy in some spots, and a few times were guys were playing on their own ball and holing some putts to just kind of keep plodding along. You get a few more reps -it's still early in the season, right, for Mid-Am golf, if you will. So yeah, it's been great, and the venue is absolutely fantastic.

Q. It's hosted a U.S. Women's Open here and U.S. Amateur here in two events.
